This 2021 COVID-19 Acknowledgement and Release-Minor (this “Agreement and Release”) is executed by the undersigned parent or guardian of the minor named above as of the date indicated below in favor of Rebuilding Together Arlington/Fairfax/Falls Church, Inc. and Rebuilding Together, Inc.

The health, safety and welfare of our volunteers, staff, and the homeowners we serve as well as their family members is a high priority for Rebuilding Together Arlington/Fairfax/Falls Church, Inc. (“RT- AFF”). We are closely monitoring the outbreak of coronavirus disease 2019 (“COVID-19”). In order to continue RT-AFF’s mission of repairing homes and revitalizing communities in these trying times, we have created Worksite Safety Protocols, which must be followed by our volunteers and homeowners to help prevent the spread of the disease.

Set forth below is my acknowledgement that I on behalf of myself and the named Minor, we have received and reviewed the Worksite Safety Protocols, our recognition that even if the Protocols are followed, there is a risk that the Minor or a family member may contract COVID-19, and a release whereby we agree to release RT-AFF as well as Rebuilding Together, Inc. from all claims that may arise from my exposure to COVID-19.

- We have received and reviewed a copy of RT-AFF’s Worksite Safety Protocols.
- We agree to adhere to the Protocols at all times. We recognize these measures are intended to protect the Minor, the homeowner, other occupants, other volunteers, RT-AFF staff, and contractors from the risk of exposure to COVID-19 while the repairs are being made.
- We understand that we are responsible for notifying RT-AFF in the event the Minor experiences symptoms or receive a positive diagnosis, or if the Minor has had direct contact in the past two weeks with someone else experiencing symptoms/received a positive diagnosis, and agree to provide accurate and honest information.

**With full awareness and appreciation of the risk that the Minor may be exposed to and contract COVID- 19 as a result of the Minor’s participation, either as a homeowner, occupant, volunteer, or contractor in RT-AFF’s provision of repair and renovation services to homeowners in Arlington, Fairfax, and Falls Church, Virginia, we as the Minor and the parent or legal guardian of the minor named above and on behalf of my family, heirs and assigns, hereby covenant not to sue and release, waive and discharge RT-AFF, Rebuilding Together, Inc., Arlington County, Fairfax County, and all of their respective officers, directors, employees, contractors, agents and volunteers from any and all liabilities, claims, damages, injuries, demands, actions and causes of action of any kind, arising out of or related to my exposure to COVID-19. We agree that this Acknowledgement and Release governs all of my involvement with RT-AFF projects during the calendar year 2021 and that we will need to sign a new Acknowledgment and Release for any project activities that the Minor is involved with during any succeeding years.**
